## THE BIDEN TIMELINE AND THE PLOT TO REMOVE DONALD TRUMP

3/01/2014

Neil Callahan of Rosemont Seneca sends Hunter Biden and Rob Walker (also from Rosemont Seneca) an email with the Subject: "Crimea: A Gift To Ukraine Becomes A Political Flashpoint: Parallels: NPR." The content of the email is simply a link to this NPR story [HERE](#). It is likely that Burisma is already on the radar of at least Devon Archer.

3/05/2014

Sally Painter, Co-Founder of Blue Star Strategies, (USUBC/Burisma Lobbyist/Clinton and Biden) emails an Op-Ed about McCain and Ukraine to her contact list. The article is on the website of The Truman Project, of which Hunter Biden is a Director on the Board. The article is [HERE](#)

03/15/2014

Devon Archer sends Hunter Biden an email which is just a forward of a NYT article titled "[Russian Troops Seize Gas Plant Beyond Crimean Border, Ukraine Says](#)"

03/16/2014

Hunter Biden emails an article to Devon Archer titled, "Joe Biden Lurks Behind Every US Action on Ukraine". Archer responds by saying, "This is unique timing here in this upcoming opportunity. One door closes, another opens."

03/06/2014

Hunter Biden emails Devon Archer about the State Department imposing visa bans for people who have taken steps to undermine Ukraine's territorial integrity. Apparently Archer was in Ukraine at this time because he jokes about not being able to "make it home" and Hunter says he will contact Devon's "SEAL buddies" to retrieve him "Commando Style".

03/16/2014

Hunter Biden emails Devon Archer with concerns that the Ukraine situation may harm BHR (Bohai-Harvest-Rosemont) and "spook" Chinese investors. He says, "It's not a good thing for our BHR Strategy." Archer seems more optimistic about their Chinese partners seeing opportunities in the conflict.

04/12/2014

Biden family associate Alexander Mackler sends Hunter Biden, Joe Biden, Eric Schwerin and Ted Kaufman a link to a [presentation](#) given by Kaufman about Ukraine. In this presentation, Kaufman speaks about NGO involvement on "educating voters" in Crimea.

04/12/2014

A White House [press release](#) is issued announcing that Joe Biden would be traveling to Ukraine to consult with the Ukrainian government on a variety of issues (including "energy security").

A day prior, on 04/11/2014 Former US Ambassador and Atlantic Council Advisor Daniel Fried met with Senior Director of European Affairs for the National Security Council, Karen Donfried.(SOURCE: White House visitor logs)

04/15/2014

Devon Archer schedules an appointment for the next day in the West Wing with Joe Biden. (SOURCE: White House visitor logs)

He will later say the pretext was that his son had a school project that he needed to speak with Joe about.

04/16/2014 (11:30AM)

Devon Archer meets with Joe Biden in the West Wing of the White House at 11:30am. No notes/records of the meeting are published. (SOURCE: White House visitor logs)

(Same Day)

04/16/2014 (12:00PM)

30 minutes after the Archer/Biden meeting begins, Senior Foreign Policy Advisor to Joe Biden, Michael Carpenter meets with the following:

- 1: Former Dept of State Russian Affairs and current USAID Eurasia official, Suren Avanesyan.
- 2: Former Dept of State and current USAID Eurasia official, Jonathan Katz.
- 3: Department of Energy for Europe and Eurasia official, Andrea Lockwood.
- 4: Department of Energy for Russian and Eurasian Affairs, Jess Bahnak.
- 5: Current Deputy Assistant Secretary for Investment, Energy, and Infrastructure, Jeffrey K Baker (Nominated in 2021 by Joe Biden).
- 6: Michael Carpenter also meets with former Ukrainian Governor, Serhiy Taruta. (SOURCE: White House visitor logs)

Also, at the same time, Atlantic Council Advisor and former Ambassador, Paula Dobriansky met with Celleste Wallander, Deputy Asst Secretary of Defense for Russia/Ukraine/Eurasia. (SOURCE: White House visitor logs)

04/17/2014

Hunter Biden emails William Isaacson at Boies, Schiller, Flexner asking to set up a call with Burisma Holdings Ltd. "Burisma is ready to engage the firm...Burisma is the largest independent energy producer in Ukraine..." Also stating, that the call will include "Devon Archer who is my business partner at Rosemont Seneca and affiliated with Burisma". There are 18 emails exchanged between all parties to arrange this call. Devon says "please send around call information to Vadim and me for 10am EST with Boies"

04/18/2014

Hunter Biden is official named a Burisma Board Member according to the [NY Post](#). Also, Former Ambassadors to Ukraine, and Atlantic Council Advisors, Roman Popadiuk and John Herbst (Herbst would later go on to be directly involved with Burisma's funding of The Atlantic Council), meet with Biden NSC Advisor, Jake Sullivan.

04/21/2014

Joe Biden arrives in Ukraine.

04/22/2014

[Reuters reports](#): "Briefing reporters on board Biden's plane [a senior administration] official said the assistance was made up primarily of technical know-how to help boost energy efficiency as well as production in Ukrainian natural gas fields and extraction of 'unconventional gas resources'...ie 'fracking'. There were three major companies holding fracking leases in Ukraine. Two American lease holders suspend operations due to the conflict. That leaves Burisma as the only potential beneficiary of US aid.

05/15/2014

With some US Media pushback on his role in Ukrainian energy at Burisma, Hunter emails friend John Blount, and gives what will become his usual line when embroiled in any type of business scandal, "I am an independent director w/ no equity interest and my only commitment is to attend (by phone) quarterly board meetings."

Biden associate Andrew Schwartz also suggests Hunter connect with Dan Glickman from \*Aspen Institute about strategizing damage control.

07/2014

According to Georgette Spanjich of ML Strategies, Burisma lobbied many "US Government officials in July"

06/07/2014

ML Strategies and David Leiter are on board representing Burisma as a lobbyist. It is in this time frame that Shokin personally opens the investigation into Burisma at the request of the UK as part of an unlawful-enrichment probe.

10/25/2014

Vadim Pozharskyi sends an email to Dave Leiter/ML Strategies staff, as well as, Alan Apter, Devon Archer, Hunter Biden and Jamie Robertson (of FTI Consulting) stating the following: "I would like to let you know that following my working visit to Washington DC, our company has started cooperation with USAID". (Source: Biden Laptop)

11/02/2015

Burisma Exec Vadym Pozharskyi emails Devon Archer, Hunter Biden and Eric Schwerin demanding meetings with top US officials and says, "the ultimate purpose to close down for any cases/pursuits against Nikolay (Zlochevsky) in Ukraine." Joe Biden demands Shokin be fired 3 months later. A new prosecutor is installed and the American attorney for Burisma (affiliated with Blue Star Strategies), John Buretta settles the case against Burisma/Zlochevsky with no criminal charges and a small tax payment. (Source: Biden Laptop)

01/19/2016

Shokin returns to the Burisma investigation. On 01/19/2016, Eric Ciaramella, Liz Zentos, and a bevy of Ukrainian officials and prosecutors meet in Washington DC. Attendee Andriy Telizhenko has said the meeting was to ask Ukraine to stop investigating Burisma and let the FBI handle it, and to instead investigate Paul Manafort. Strangely, nine days later, Antony Blinken's office forwarded an email to a redacted Hotmail account. It was an email where Hunter Biden had tried to schedule time with Blinken to "get your advice on a couple of things", from a year earlier. The email was retrieved and forwarded to the redacted account after the Ciaramella meeting. (Source: Biden Laptop)

JAN -MAY/2015

The UK Closes it's Burisma investigation . The Ukraine investigation into Burisma continues.

On 4/17/15 Vadim Pozharskyi emails Hunter Biden thanking him for the opportunity to meet his father, Joe Biden.

John "Ivan" Hynansky (Friend of Joe Biden), loans Jim Biden approximately 500K dollars for his mortgage. The home was later sold to Giuliani donor Randall Stofft.

FEB-MARCH/2016

Days before the Shokin firing and the "Quid Pro Joe", Burisma hired PR Firm Blue Star Strategies (Co-Founder, Sally Painter/Friend of Hunter Biden) who met with Ukrainian Embassy officials in Washington DC to set up a meeting with the prosecutor's office at the time of Joe's visit to Ukraine. (Source: The Hill)

Eric Ciaramella meets with numerous financial crimes advisors and FBI agents, reportedly to discuss the Paul Manafort Ukraine issue. Bruce Ohr emails Christopher Steele and dicusses Oleg Deripaska, who would be traveling to the United States. Ohr tells Steele that someone has asked that all documents be filtered through him (it is suspected, because of the redaction context, that this person is Eric Ciaramella).

## FEB-MARCH/2016

A few weeks after the Blinken email forward, on 02/24/2016 Karen Tramontano, Co-Founder of Blue Star Strategies, requests a meeting with Under Secretary Novelli about recent comments he made concerning Burisma being corrupt. She name drops Hunter Biden in the email specifically in what appears to be her attempt to secure the meeting.

Shokin's firing is announced. John Buretta (former EDNY colleague of USUBC Senior Advisor, \*Tom Firestone), represents Burisma in the Ukraine investigation and asks to speak with the new prosecutor in the case. His request is denied. \*(More on Firestone in the supplemental materials)

Tramontano will later testify that she brought up Burisma to Ukranian officials Andryi Telizhenko and Oksana Shulyar during a private meeting. Shulyar and Telizhenko would later be famously solicited by DNC employee Alexandra Chalupa for damaging information concerning the Trump Campaign.

Elizabeth Zentos and Eric Ciaramella meet with Telizhenko at a DC Restaurant called "The Exchange". Telizenko is later discovered to be an ally of Rudy Giuliani.

## 0?/2016

After Yuriy Lutsenko is installed as the new prosecutor John Buretta secures a meeting with him to discuss the case/investigation of Burisma. Burisma agrees to settle with Ukraine for a fraction of their owed taxes to close all criminal cases. It is widely viewed by the Ukrainian people as a bribe. When asked who invited him to join Burisma, Buretta says, "On the recommendation of other highly-regarded US Advisors, I met with Bursima's management and legal team, and Burisma's 'distinguished' Board of Directors." The settlement is announced in January of 2017. (SOURCE: [KYIV POST](#)) Former Buretta colleague Tom Firestone has introduced Simon Kukes to Kathleen Kavalek (State Department). Kukes will later become featured in the "Steele Dossier" (SOURCE: [FOX NEWS](#))

## 02/01/2017

John Buretta's interview is published in the Kyiv Post and creates a problem for Joe Biden's narrative. Biden claimed there had been no investigation into Burisma at all when he demanded Shokin fired. Buretta's interview indicates it was open well into the end of 2016.

2/20/2017 Trump appoints HR McMaster to the position of National Security Advisor. His "Personal Aide" is a CIA and NSC Analyst named, Eric Ciaramella.

## 01/26/2019

Rudy Giuliani meets with Yuriy Lutsenko. The House Impeachment Report claims they spoke about whether or not Marie Yovanovitch was "loyal to Trump". The USUBC (US Ukraine Business Council) website shows that on at least two seperate occasions in 2017, Marie Yovanovitch presented with Vadim Pozharskyi of Burisma at USUBC events. Pozharskyi and Burisma Executives on another occasion attended a presentation/event at the Ambassador's private residence in Ukraine.

## 05/28/2019

William Taylor accepts an offer from Mike Pompeo to become Ambassador to Ukraine as a replacement to Yovanovitch. It's an interesting choice considering Taylor is a long time USUBC guest speaker and not a Trump supporter. The USUBC was partially funded by Burisma (who was a member), and had other members/supporters such as Tom Firestone, David Kramer (who personally picked up the Steele Dossier for John McCain), Baker&McKenzie law firm, Blue Star Strategies, COFCO (a strategic partner of Hunter Biden's BHR in China), The Chinese Commerce Association, Kurt Volker, BGR Group, Democratic Congresswoman Marcu Kaptur, Michael Bleyzer, Paula Dobriansky, George Kent, Marie Yovanovitch, The Atlantic Council, CSIS, Blue Star Strategies, Paul Zalucky (Former CIA), and many more.

## 08/12/2019

The official "Whistleblower" complaint is filed by Eric Ciaramella.

## 04/2016

On 04/06/2016, Sally Painter, Karen Tramontano and John Buretta meet with interim Ukrainian prosecutor Sevruk. They apologize "for the dissemination of false information by US representatives and public figures on the activities of the Prosecutor Generals office in Ukraine and in regards to the investigation of criminal activities of Zlochevsky" and offer to set up DC meeting for new Ukrainian prosecutor. (SOURCE: Sevruk Memo)

On 04/27/2016 Victoria Nuland is in Ukraine with Charles Kupchan. Kupchan is Eric Ciaramella's mentor and boss at the NSC. (SOURCE: [USUBC](#))

## 09/19/2016

President Obama sends a Presidential Delegation to attend the "Commemoration of the 75th Anniversary of the Babyn Yar Massacre in Kyiv Ukraine". The two administration officials he sends are Marie Yovanovitch and Charles Kupchan.

## 01/2018

Biden, at the Council for Foreign Relations (home to many anti-Trump members, including Eric Ciaramella and Sean Misko), retells the "Quid Pro Joe" story of threatening to withhold 1 billion dollars in aid unless Shokin was fired.

## 04/15/2019

According to [FARA records](#), a "mysterious" lawyer named Marcus Cohen begins lobbying members of the Trump Administration and National Security Council on behalf of Ukraine's new President Zelensky . On 4/15/2019 Cohen meets for the first of many times with Alexander Vindman. It should be noted that Marcus Cohen was an attorney at Baker&McKenzie, the same firm that the aforementioned Tom Firestone is a partner at. Zelensky has since denied any association with Cohen. Cohen also met with Sean Spicer, Mike Rubino, and Matt Mowers.

Vindman was on the infamous trip to Ukraine with Kurt Volker and Rick Perry. Perry would later pressure Trump personally to make the call to Zelensky, which would later lead to impeachment. Giuliani had been in Europe investigating Ukrainian election involvement. A top donor to Giuliani and Perry is Michael Bleyzer. Bleyzer is Ukrainian born American and major funder of the USUBC..

## 07/25/2019

Trump, on the recommendation of Rick Perry, initiates a call with President Zelensky to bring up the topic of Burisma and possible Biden corruption in Ukraine. Listening in on this call is the likely real Whistleblower, Alexander Vindman. It is suspected that Vindman told Ciaramella, who took the initiative to file the complaint. This is 3 months after Vindman was lobbied by Marcus Cohen.

\*[Michael Bleyzer](#) of the USUBC (Primary funder) was a large donor to Perry (30k for his run for Governor) and [Giuliani](#) (Maximum Presidential Campaign contribution). Giuliani's law firm was hired by Bleyzer in 2008 where it helped it aquire cable television holding in 16 Ukrainian cities. A month after Perry attended Zelensky's inauguration in Ukraine, [Michael Bleyzer](#) received a lucrative 50 year drilling contract in Ukraine

## 02/05/2020

Donald Trump is acquitted of abuse of power by a Senate vote of 52-48.

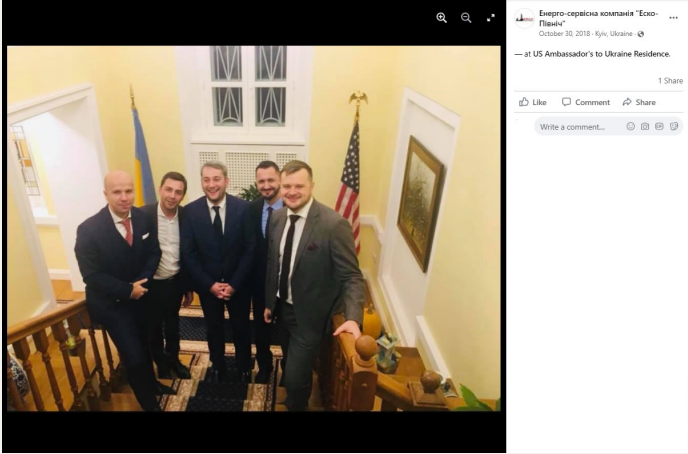
